
WHY A YOUTH MEAT ANIMAL Program:

SALE ORDER OF ANIMALS:

Sale order alternates every year.

Sale Order:

- 1. Meat Goats
- 2. Sheep
- 3. Poultry
- 4. Swine
- 5. Rabbits
- 6. Beef

AUCTION OPTIONS FOR BIDDERS/ BUYERS:

Option #1 – Buyer(s) purchase animals outright (by the pound for beef, sheep & swine and by the unit for meat goats, poultry and rabbits).

Option #2 – Buyer(s) purchase animals (beef, sheep and swine) on support price basis. The support price is the difference between that day's market price per pound and the buyer's final auction price per pound.

- Average market price will be determined from the USDA price at close of market on Friday and will be announced.
- Buyers will indicate, at time of purchase, if they are buying the animal outright (option #1) or for support price (option #2)
- Four percent of purchased price is retained for the costs incurred in conducting the show, sale and its promotion, and scholarships & youth educational seminars.

TERMS REGARDING PAYMENT:

Buyer agrees to pay balance in full within 15 business days. Late payment is subject to a 5% late charge fee.

PICTURES:

Picture immediately following sale of animal in sale ring.

RESPONSILITY OF SELLER:

Project members must continue to feed and care for the animals throughout the entire fair. Exhibitors must be present to load animal for market and complete transfer of ownership.

SELECTION OF PROCESSOR:

For each animal purchased outright the buyer will select a processor. Slaughter costs are determined by the processor. The buyer is typically charged a harvesting charge and a fee per pound of the carcass weight for cutting, wrapping and freezing.
